4. APPROVAL OF SUMMARY MINUTES, April 24, 2008, General Assembly*

President Jacobs Gibson recognized a motion and a second to approve the minutes of the General Assembly of April 24, 2008. The motion passed unanimously.

5. PRESIDENT'S REPORT

President Jacobs Gibson reported on the following:

ABAG has been busy implementing the strategic plan, including looking for ways to secure a consistent source of revenue. ABAG has worked with State Senator Mark DeSaulnier, County of Contra Costa, to introduce SB 406 which, if adopted, will provide a source of income to the regions and to cities and counties for planning and implementation of SB 375.

ABAG appointed the members of the newly authorized San Francisco Bay Restoration Authority, whose purpose is to raise and allocate resources for the restoration and enhancement, protection, and enjoyment of wetlands and wildlife habitat in the San Francisco Bay and along its shoreline. The first meeting of the Authority was April 22.

Staff will distribute an ABAG lapel pin to members.

6. PROPOSED ANNUAL BUDGET AND WORK PLAN – Fiscal Year 2009-2010*

President Jacobs Gibson recognized Executive Director Henry Gardner who presented a summary of the Annual Budget and Work Program for fiscal year 2009-2010, which includes a proposed six percent increase in member dues.

President Jacobs Gibson recognized a motion, and a second, to approve the budget and work program by counties. The county vote on the motion was eight (8) ayes, zero (0) nays, and the motion passed unanimously.

President Jacobs Gibson recognized a motion, and a second, to approve the budget and work program by cities. The city vote on the motion fifty-six (56) ayes, zero (0) nays, and the motion passed unanimously.

7. PROPOSED BYLAW AMENDMENT

President Jacobs Gibson recognized Legal Counsel Kenneth Moy who presented a proposed change in the Bylaws to accommodate flexibility in scheduling the Spring General Assembly.

President Jacobs Gibson recognized a motion, and a second, to approve the proposed Bylaw amendment by counties. The county vote on the motion was eight (8) ayes, zero (0) nays, and the motion passed unanimously.


