Staff Announcements

-Thompson

Highlighted recent press in the San Jose Mercury News as part of the "Eat, Drink, Play" series and noted that map sales and Facebook activity increased substantially as a result of the coverage. Announced there is a scheduled Bay Trail presentation at SPUR by Thompson and DeBra in San Francisco on July 23. Presented the new Bay Trail notecards made possible by board member Julia Miller. Announced the release of a request for qualifications for art curatorial services to support the Bay Trail *Migrations* project.

Announced a successful May 31 Ferry Point Loop dedication sponsored by TRAC and the City of Richmond. Over 200 people attended this ribbon-cutting to celebrate the new Bay Trail segment next to the Plunge and the completion of the Ferry Point Loop. The event demonstrated the importance of local advocacy and partnerships and was attended by many elected officials. On June 15 at 4:00 p.m., a section of the Wildcat Creek Trail connector in San Pablo will open. On Saturday, July 25 Pedal Fest will be held in Jack London Square in Oakland, hosted by Bike East Bay. The Bay Trail will have a display table.

Announced the release of a request for qualifications for the Bay Trail website re-design. We anticipate a map set update in the next four or five months to reflect new trail sections that have been built since the last printing. The Point by Canogle smart phone tours for the Bay Trail have over 1,000 downloads so far. Staff will find out which tours are the most popular downloads. Canogle will host four Meet-Up events this summer to showcase the tours. Announced that CA Department of Fish & Wildlife completed a section of Bay Trail in Napa near the airport by updating an existing gravel levee. However, Napa County has objected to having the trail along the airport levee. While the trail is open, access is not yet legal because of the need for a formal railroad crossing.

Introduced himself as the new Bay Trail/Water Trail Planner. He is primarily working on the Water Trail and will take on Bay Trail projects over time. Prior to coming to ABAG, he worked with an environmental consultant firm on CEQA/NEPA projects. In Santa Barbara, he worked on implementing a segment of the Coastal Trail. The Committee welcomed Ben to the team.

Introduced himself and his company, SD Mayer & Associates. Mr. Mayer described his enthusiasm for the Bay Trail and plan to organize a walk/bike event on October 18. Through outreach conducted by his firm, the event would encourage people to walk or bike all complete sections of the Bay Trail. The goal of the event is to increase awareness of the Bay Trail and secure donations for its completion. Bay Trail staff will assist Mr. Mayer and his team in connecting with local jurisdictions and providing maps of complete sections of Bay Trail.

Consider Support for AB 40 (Ting) Protecting Golden Gate Bridge Access

Gaffney provided a summary of the Golden Gate Bridge District's proposal to consider charging tolls for bicycle and pedestrian access on the bridge. She shared recent letters written by the Bay Trail Project against this proposal. Legislation sponsored by Assemblymember Phil Ting would prevent the Bridge District from charging tolls to non-motorized users.

ACTION:

Bondurant moved, Wenger seconded the motion to support AB 40 (Ting) to protect free bicycle and pedestrian access on the Golden Gate Bridge. The vote was approved unanimously.

Bay Area Ridge Trail Council - Climate Ready Grant Contribution from Bay Trail Nonprofit (\$15,000)

Thompson provided an overview of the Climate Ready Grant demonstration project that will explore greenhouse gas emission reductions along the South Bay Loop Trail network in San Jose. Staff requested Steering Committee approval for a contribution of \$15,000 to help finance the work of EcoShift, the consultant selected to lead the team.

The Committee discussed the request, with several comments: It would be great if this analysis helped planners with CEQA questions about the benefits of trails and GHG/VMT reductions; questioned why MTC and VTA aren't funding this study; expressed hope that highlighting San Jose's program and trail counts will inspire other cities to do the same; pointed out that the Bay and Ridge trails are different, and asked whether this would be highlighted in the study; commented that it would be helpful to include the length of trail and its impacts on usage, i.e., longer trails have benefits that are perhaps more significant; raised question of what the Bay Trail Project would get out of this, wanting to make sure it benefits the project; Conservancy commented that the Climate Ready grant program was very competitive and the project scored high.

ACTION: Wenger moved, Bondurant seconded the motion contribute \$15,000 to the Bay Area

Ridge Trail Climate Ready Grant. The vote was approved unanimously.
