Housing Package Signed by the Governor

Governor Brown signed the 15-bill housing package passed by the California Legislature in September. The bills include new permanent funding, a one-time jolt of new money and certain reforms as required by the Governor to gain his support for the funding elements of this housing legislation package.

Webinar: Bay Area Model Solar Ordinance October 23rd, 2 to 3:30 p.m

Local government staff are invited to join the Bay Area Model Solar Ordinance webinar for an in-depth review and discussion on the Cost Effectiveness Study in the solar toolkit, on Monday, October 23rd, from 2 - 3:30 p.m.



Participants will learn how to meet renewable energy and climate action plan goals through the adoption of a rooftop solar photovoltaic (PV) ordinance and explore the process of adopting rooftop solar PV ordinances on new residential and low-rise multifamily construction. This is the first in

a series of bi-monthly work sessions hosted by the Bay Area Solar PV Ordinance program.

Work sessions will convene technical experts, as well as regional and local partners, to discuss challenges encountered through the adoption of a basic ordinance and provide information on ordinance enhancements. This work session is in partnership with the Statewide Energy Codes & Standards team and features an in-depth review of the Bay Area Solar PV Ordinance Cost Effectiveness Study.
