## San Francisco Bay Restoration Authority Closes First Call for Proposals



The first Request for Proposals (RFP) for the new San Francisco Bay Restoration Authority grant program, created through the voter-approved Measure AA on the June 2016 ballot, closed on November 15, 2017. The grants will fund shoreline projects that will protect and restore the Bay.

The San Francisco Bay Restoration Authority is a regional agency with a Governing Board made up of local elected officials. Its purpose is to raise and allocate local resources for the restoration, enhancement, protection, and enjoyment of wetlands and wildlife habitat in San Francisco Bay and along its shoreline, as well as with associated flood management and public access infrastructure.

The Restoration Authority was created by the California Legislature in 2008 to find solutions to the need for new, local funding, due to reduced funding from other sources. After the Authority voted to place Measure AA, the San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure, on the June 7th, 2016 ballot, residents of the nine-county San Francisco Bay Area voted with a 70 percent majority to pass it. This measure is a \$12 parcel tax, which will raise approximately \$25 million annually, or \$500 million over 20 years.

# Working Towards the Bay Area Regional Economic Development District

Staff are presenting a Comprehensive Economic Development Strategy (CEDS) to each County Board of Supervisors and requesting endorsement of the CEDS Vision, Goals and Objectives.

San Francisco and Contra Costa counties have already endorsed the Strategy and meetings are scheduled with Alameda, San Mateo, and Santa Clara county supervisors in December. This work is part of the effort to create a Bay Area Regional Economic Development District (EDD) as designated by the U.S. Economic Development Administration (U.S. EDA).

## **Draft Regional Resilience Report Now Available for Public Comment**



The Bay Area is facing the impacts of climate change and other hazards today, and will face more extreme events in the future.

A new report, *Raising the Bar on Resilience* (November 2017 draft) is a call to action by the Bay Area Regional

Collaborative (BARC) and its member agencies - the Association of Bay Area Governments, Bay Area Air Quality Management District, Bay Conservation and Development Commission and Metropolitan Transportation Commission. The document proposes a comprehensive regional planning process and a new integrated Regional Resilience Plan to prepare the Bay Area for the challenges ahead related to flooding, rising sea levels, climate change impacts, seismic events and other hazards.

This report offers six steps to take towards regional resilience and four case studies (San Rafael, East Palo Alto, Oakland, Hayward). BARC is accepting public comments on the draft report until January 15, 2018.

## New Public Art Grant for San Francisco Bay Trail in Redwood City

The City of Redwood City announced the award of a \$25,000 National Endowment of the Arts (NEA) grant to support a new public art installation called the Pirate Ship, located on the San Francisco Bay Trail. The grant award

will support community engagement activities and design planning for the public art installation.

The Pirate Ship was created by artists Ilya and Emilia Kabakov and will be designed as a fully functioning art sculpture and a permanent feature offering an imaginative play space and library space next to the Redwood Shores library branch. The art installation will serve the community at large

by encouraging fantasy, conversation, social interaction, and play. As part of the public art process, the artists will work directly with park designers and the community to fully integrate the structure into the site location.

The NEA grant will be used to support the oversight, youth art competition and the development of the Pirate Ship shade sails. The grant award will be used to support a local effort with school children in Redwood City to illustrate and publish a short story, which will feature local children's drawings.

The Pirate Ship is the first permanent art work of Migrations, a local collaboration between the Bay Trail, Association of Bay Area Governments, City of Redwood City, Redwood City Civic Cultural Commission and Fung Collaboratives. Migrations is a public art initiative to support art along the Bay Trail. The City of

Redwood City was the first local government agency to support Migrations within San Mateo County.

With the assistance of the NEA grant and following extensive community engagement through design meetings, the Pirate Ship installation is planned to open in 2019.
