FROM THE EXECUTIVE DIRECTOR

A year ago it would have been relatively hard to imagine that the state would be faced with a \$14 billion dollar deficit over the next eighteen months. But a year ago the economy was not faltering, we had yet to hear or understand much of what was happening with residential real estate mortgages and the impact it would have on the overall economy, and the impending widening gap between revenues and expenditures was not evident. Some are estimating that the \$14 billion deficit will have grown even larger by the time the governor and legislature

come up with a balancing strategy. This is ominous for cities and counties, and indeed all public agencies dependent upon state funding. Given the magnitude of the deficit, very deep cuts are likely to be made in a number of programs and services. By the time this document

reaches you the governor will have already given his state of the state address and called the legislature into special session. It will no doubt be a long winter, a long spring, and a very long summer before we have an adopted budget.

FY 2006-07 was a very busy time for ABAG. We completed the state mandated Regional Housing Need Allocation (RHNA) process and are now in the appeals period. We, along with MTC, were successful in securing a second round of funding for our Blueprint Planning process known as Focusing our Vision (FOCUS). We adopted more than 100 Priority Development Areas (PDAs) and have received 142 nominations for Priority Conservation Areas (PCAs). These numbers far exceeded our expectations. Clearly our member jurisdictions are interested in planning for the future in a way that identifies appropriate areas for development and areas that are community and regional assets that should be preserved and protected.

We conducted a number of conferences and symposia covering such topics as Other Post-Employment Benefits (OPEB) obligations, housing supply and affordability, earthquake and other disaster preparedness and recovery, Regional Economic Outlook Conference 2007, the eighth biennial State of the Estuary Conference, Greening Infill Conference, Successful Community Engagement workshop, and the spring and fall general assemblies: "Focusing our Vision" and the joint ABAG/MTC "Bay Area on the Move" Summit. Literally thousands of individuals have attended these conferences and symposia and the evaluations from participants have been excellent.

Recognizing that many of our elected officials are not able to attend all of our conferences and symposia, we are planning to do a series of regional mini presentations of some of the topics covered in an effort to reach as many of you as possible.

As you will see from the program and service descriptions included in this report, ABAG is engaged in a variety of areas designed to support our members. The ABAG Finance Authority has issued tax-exempt bond financing for housing, hospitals, schools, nursing homes, and many other facilities totaling hundreds of millions of dollars. Our Energy Watch program, Bay Trail, Green Business, Hazardous Material training programs, and ABAG PLAN in some way are providing services in virtually every member jurisdiction.

In accordance with the previously approved policy by the General Assembly, membership dues for FY 2008-09 shall be adjusted based on the Bay Area CPI. The proposed increase is 3.19%. The increase applies to the per capita rate and the fixed fee portion of the membership dues. The budget for FY 2008-09 will be presented to the General Assembly in April for adoption.

2008 will be a challenging year given the state's fiscal crisis. On the other hand we see the possibility for some exciting and creative work in the areas of climate change, priority development and conservation, energy efficiency, and regional collaboration around land use and transportation. We look forward to working with each of you.

The year 2007 presented many firsts, new challenges, and opportunities for ABAG. The Executive Board oversaw the convening of two General Assemblies that drew large numbers of elected officials, staff, and civic leaders from throughout the region. The first of these in the spring showcased the leadership of the mayors of San Francisco, San Jose, Oakland, and Petaluma, four very different cities, each working on the issues of concern to the region. They spoke of the need for regional collaboration, discussed the areas where local and regional needs intersect and the need for our collective environmental stewardship. The presence of Mayors Reed, Newsom, and Dellums represented the first time in recent history

The Cities of San

Mateo and Pleasant Hill, and the Town of Windsor along with the County of Napa were presented with ABAG's first *Growing Smarter Together* Awards during the Spring General Assembly. Each awardee was presented with a plaque in the shape of the region and a copy of a video prepared by Comcast. Nominations for the 2008 Awards Program are now being accepted for presentation during the Spring General Assembly.

The Fall General Assembly and Transportation Forum jointly sponsored by ABAG and MTC and co-sponsored by the Bay Area Air Quality Management District and the Bay Conservation and Development Commission represented the first time that ABAG and MTC have jointly sponsored a major General Assembly/Forum. This is significant in that it underscores the partnership of the two agencies in addressing the land use and transportation challenges faced by the region that together we are addressing through the FOCUS Initiative and

Transportation 2035, the Regional Transportation Plan. More than 800 people registered for the GA/Forum, which received tremendous media coverage and participation by elected officials, members of the public, civic leaders, and key stakeholders. A key feature of the day was the opportunity for participants to weigh in on the issues by electronic key pad voting with real-time feedback.

One of the least popular issues that ABAG and other Councils of Governments are required to address is the state mandated Regional Housing Need Allocation Process (RHNA). The Executive Board adopted the final 2006-2014 RHNA numbers at its November Meeting and a 60-day appeals period commenced. For the first time since we have been notably conducting RHNA, the County and Cities in the County of San Mateo opted to take advantage of the new provision permitting a subregional approach. They developed a sub-

regional methodology for the allocation of housing units based on the countywide number provided by ABAG. ABAG and other Councils of Governments will continue to advocate for change to the way this state-mandated

program is carried out. While we recognize and support the need

for housing development for all income levels, we know that there is a better way.

During 2008 we will finalize the Agency's strategic plan that we have worked diligently to complete over the last year. We have heard from you, our members, and from the staff about ways that ABAG can be more meaningful and provide value added services. We will continue to work hard to incorporate your feedback and add to the programs and services currently offered. We also invite you to let us know how we're doing and encourage you to participate in the General Assemblies and workshops offered by ABAG.

2008 will present many challenges, but working together we will be able to find the opportunities that lie just beneath each challenge.

Fiscal Year 2008-2009 will be a momentous time of change for the Association of Bay Area Governments' (ABAG) Planning Programs. ABAG is transitioning from a successful visioning phase in 2007-2008 to the implementation of FOCUS, a multi-agency development and conservation strategy for the Bay Area led by the Association of Bay Area Governments. Through the provision of a new planning grant program funded by our partner agency, the Metropolitan Transportation Commission (MTC), ABAG will support and facilitate inclusive and collaborative planning within the Priority Development Areas (PDAs). We will work with local jurisdictions and our partner regional agencies to reward development in existing communities that is compact, transit-oriented, provides for the needs of existing and future residents, and is resource conserving and socially equitable. ABAG will also work in its leadership role related to conservation, by collaborating with public resource agencies, local governments, and the region's open space entities to identify and secure funding for those scenic and natural resource areas that are the Bay Area's conservation priorities.

The paragraphs below provide an overview of ABAG's planning initiatives related to regional land-use planning, with descriptions of the agency's well regarded and closely-related planning programs that focus on particular issues following. Noted programs include the Bay Area Alliance for Sustainable Communities, Bay Area Green Business Program, Earthquake and Hazard Mitigation and Preparedness, the San Francisco Bay Trail, and the San Francisco Estuary Project.

FOCUS

FOCUS is a voluntary, incentive-based development and conservation strategy for the Bay Area. It is a multi-agency initiative led by the Association of Bay Area Governments with support from the Metropolitan Transportation Commission (MTC) as well as the Bay Area Air Quality Management District (BAAQMD) and the Bay Conservation and Development

Commission (BCDC). FOCUS identifies preferred areas for development and conservation and directs financial incentives, resources, and support to those areas. Acknowledging that land-use authority rests with local governments, this approach attracts local jurisdictions committed to more compact development and encourages cities to develop in ways that are sensitive to local needs and concerns, while at the same time moving toward achieving the regional goals of increased transportation efficiency, more housing, and environmental protection.

The FOCUS Initiative emphasizes planning for complete communities, not just for isolated infill projects. The objective is the achievement of areas that are well planned with good housing choices, transit options, and private and public services available to address the needs of both current and future residents. By promoting complete communities that work better for everyone, jurisdictions will find it easier to garner community support for new development and will experience greater success with project implementation. Complete communities are also more effective at moderating traffic and growth in Vehicle Miles Traveled (VMT) because residents can walk and bike to many everyday needs and connections to transit are enhanced. Successful projects can serve as models to other jurisdictions developing compact communities and help to further regional goals.

The goals of FOCUS include the following:

- Strengthen and support existing communities
- Create compact, healthy communities with a diversity of housing, jobs, activities, and services to meet the daily needs of residents
- Increase housing choices
- · Improve housing affordability
- Increase transportation efficiency and choices
- Protect and steward natural habitat, open space and agricultural land
- Improve social and economic equity
- Promote economic and fiscal health

- Conserve resources, promote sustainability and improve environmental quality
- · Protect public health and safety

The distinct and prominent features of FOCUS include the identification and adoption of both Priority Development Areas (PDAs) where development can be accommodated in complete communities and Priority Conservation Areas (PCAs) representing places in the region that are resource preservation priorities. PDAs are infill opportunities near transit where incentives will be directed. These areas are within an existing community, near existing or planned transit and have an adopted land use plan with a significant housing component or a vision to develop such a plan. These communities welcome

more residents and they are committed to creating more housing choices in locations easily accessible to transit, jobs, shopping, and services. PCAs represent regionally significant open spaces that are resource preservation priorities for which there exists broad consensus for long-term protection.

In July 2007 over 50 local government entities in the region expressed interest in having PDAs in their city or

county. Together, these PDAs represent approximately three percent of the region's total land area but have selfidentified the capacity to accommodate more than half the region's projected housing growth to 2035. The ABAG Executive Board adopted a list of Planned and Potential PDAs on November 15, 2007. "Planned" and "Potential" designations are based upon "readiness" to receive available incentives. Planned PDAs are distinguished by the presence of an adopted specific plan or equivalent land use plan for the area and are eligible to apply for all incentives available through the FOCUS initiative—capital grants, planning grants and technical assistance. Potential PDAs are eligible to apply for

planning grants and technical assistance only. In addition to the striking number of PDA applications, there were over 100 areas nominated for PCA designation. In mid-2008, Priority Conservation Areas will be selected based on criteria related to regional significance, level of consensus and urgency for protection.

Regional Planning Committee

The Regional Planning Committee (RPC) is one of the agency's standing committees encompassing representation from local governments, as well as public agencies and non-profit organizations. Organizations represented on the RPC include those with an emphasis on affordable housing, education, environmental protection, equity, home building, and smart growth. The RPC



addresses planning issues of regional concern, and makes policy recommendations to the ABAG Executive Board on these issues. The RPC's important role relative to regional land use planning issues including the FOCUS Initiative will be heightened in 2008-2009 as the RPC assumes the role of the Bay Area's Regional Recovery Planning Body. Through education and coordination, the RPC will position itself to address critical, regional-level post-earthquake (or other post-catastrophic event issues) when necessary. The RPC will also work to coordinate preparedness and mitigation among the region's local jurisdictions to minimize the impacts of a major event in the Bay Area.

Clearinghouse

ABAG provides information to public and private agencies and the public related to public capital improvement projects and their potential environmental impacts.

Regional Airport Planning Committee

The Regional Airport Planning Committee (RAPC) is a joint committee of ABAG, the Metropolitan Transportation Commission, and the Bay Conservation and Development Commission. It oversees preparation of the Regional Airport Systems Analysis, a component of the Regional Transportation Plan. RAPC also provides a forum for discussion of land use, non-air transportation, and environmental issues related to airports.

Intergovernmental Coordination

In Fiscal Year 2008-2009, the level of coordination between the ABAG Planning Program and our regional agency partners, as well as local governments, will continue to change and grow. As the FOCUS Initiative evolves and planning grant processes advance in Priority Development Areas, the role of ABAG's Planning Program as a lead coordinating entity will continue to expand. ABAG's planning program provides staff support for a broad range of regional planning-related organizations including ABAG's Homelessness Task Force and the Bay Area Planning Directors' Association. Internally, ABAG works collaboratively with MTC on key land use planning issues and related analysis pertaining to the Regional Transportation Plan, Resolution 3434, and issues pertaining to transit-oriented development. As a member of the Joint Policy Committee, ABAG works with its partner agencies on a variety of critical issues including climate change.

Water Resources Planning

Water is in the forefront of most planning discussions in the Bay region. The Bay Area is facing large decisions about how to provide a coordinated, adequate, cost

effective and environmentally sustainable water supply to our nine counties and 101 cities. Communities that front on the Pacific Ocean may have a different set of concerns from those that front on the Bay/Delta, or those that have blossomed in inland areas, or along major rivers. Regardless of geography, land use planning is the driver for water supply and water quality improvement decisions throughout the region, and it has been slow to achieve the recognition it deserves. This is changing with a new knowledge that we must plan in a coordinated way or we will fail to meet state and federal mandates and our own local and regional planning objectives.

Coastal resources and coastal communities in our region help to sustain important environments and industries while offering housing, recreation, and enjoyment to millions of Bay Area residents. Recognition and response to coastal system vulnerabilities is the first step in positive change that will help our coastal areas meet new regulatory demands.

To promote positive change for our environment, ABAG is acting as a catalyst for change by linking like-minded individuals, communities and agencies with an interest in positive, joint water/land use planning and coastal protection programs. Participants include members of other regional agencies, state agencies, special districts, county boards of supervisors and planning commissions, city and town councils, non-governmental organizations, and the business community.

We envision a region where land use planning and water planning are linked to help our communities better manage their development and environmental protection needs, while providing economic opportunities in the process. Water supply and water quality improvement programs that incorporate regional development and watershed management objectives will help the Bay Area sustain its environment and our communities over the long term.

In Fiscal Year 2008-09 ABAG Planning Programs will:

- Actively participate in grant-funded Priority Development Area planning processes in local jurisdictions. The intention is to build a genuine partnership between regional agencies and local governments. Staff will serve as regional planning "extension agents" providing communities with information on best practices, links to supportive stakeholder organizations and related resources, on-call consultant services, and technical assistance. Regional planning staff will serve as a "connect-the-dots" resource for communities engaged in planning grant processes and seeking to address a variety of challenging issues pertaining to infill development in transit-served neighborhoods including affordable housing, attracting viable retail services, incorporating parks and urban greening, and integrating pedestrian amenities with new development and transit infrastructure. Regional planning staff will also serve as networking facilitators among the ongoing Priority Development Area planning efforts. Staff will actively identify shared local issues and possible solutions, so that local governments can learn from one another.
- Develop and offer a technical assistance package to all Priority Development Areas.
- Continue to develop strategies to build capacity in underprivileged communities by partnering with nonprofit organizations with well established relationships in communities of concern to build a genuine dialogue and solicit input about PDAs and issues related to this designation.
- Will adopt the first set of Priority Conservation Areas and work with public agencies and foundations to secure funding for the protection of the adopted areas.
- Will issue a second call for Priority Development Area designations and Priority Conservation Area nominations.

Regional Planning Committee

The RPC will address and make policy recommendations to the Executive Board
pertaining to important regional planning issues including considerations relative to
FOCUS Priority Development Areas and Priority Conservation Areas and the
development of programs related to Regional Recovery Planning.

Clearinghouse

• ABAG will continue its clearinghouse functions including tracking of public projects to allow review and discussion of regionally significant projects.

Regional Airport Planning Committee

 ABAG will staff and provide leadership on land use issues to advance RAPC's work program.

Intergovernmental Coordination

 ABAG will work collaboratively with local governments, our partner agencies, and stakeholder organizations to address critical land use, transportation, air quality, and water resource issues. One of the key initiatives that will be advanced is a joint agency Regional Climate Change Initiative.

Water Resources Planning

- Adding to its collection of information on water supply planning, water quality planning, coastal resources, and regional watersheds;
- Joining with scientists, the land and water planning and engineering community to help develop innovative information sources, tools and techniques to help communities meet their water and land use planning goals;
- Partnering with other agencies of government to provide needed coastal, water and land use-related resources to the Bay Area.
- Making water/land use information, tools and techniques readily available to ABAG member communities and their residents, businesses, local governments and agencies, and others with an interest in positive change.

We look forward to working with our current partners and new partners over the next several years to help them achieve their goals and ours.

BAY AREA ALLIANCE FOR SUSTAINABLE COMMUNITIES

ABAG represents Bay Area cities, towns, and counties on the Steering Committee of the Bay Area Alliance for Sustainable Communities (Bay Area Alliance). Members include public and private sector leaders committed to working together to ensure a more sustainable future. Since 1997, the Bay Area Alliance has been an agent for positive change by providing a forum where members can craft and advocate for comprehensive solutions that meet the environmental, social and economic needs of current and future generations.

The coalition authored the Compact for a Sustainable Bay Area, which recommends strategies to address the region's most significant challenges. These include improving the supply and affordability of housing; promoting a comprehensive multi-modal transportation system; preserving and revitalizing neighborhoods; restoring and protecting the region's natural assets; and strengthening the regional economy. To demonstrate how communities and organizations throughout the Bay Area are meeting these

challenges, the Bay Area Alliance has produced four installments of *Faces of Sustainability*, highlighting practices in San Francisco and in Alameda, Marin and Napa Counties.

The Bay Area Alliance was a key partner in the Smart Growth Strategy/Regional Livability Footprint Project that produced the regional "Smart Growth" Vision in 2002. As we work to implement the Vision through the FOCUS initiative, the Bay Area Alliance continues to play an important role. The Bay Area Alliance recently produced Building Communities We Care About, a video that features the personal stories of people who are living in successful transit-oriented housing developments in a number of Bay Area cities. The video will be an important tool in advancing smart growth by helping community members understand the environmental, social and economic benefits well-designed transit-oriented infill can bring.

In Fiscal Year 2008-09 the Bay Area Alliance for Sustainable Communities will:

- Support FOCUS as a way to implement key provisions of the Compact for a Sustainable Bay Area.
- Conduct targeted outreach using Building Communities We Care About to persuade the public to support transit-oriented development and smarter growth.
- Participate in the RTP process to encourage that available funds be directed to the Priority Development Areas.
- Promote the development of comprehensive climate change plans and policies that address social equity, environmental and economic issues.

HAZARDOUS WASTE ALLOCATION / BAY AREA GREEN BUSINESS PROGRAM

The Hazardous Waste Management Facility Allocation Committee

(http://www.abag.ca.gov/hazwaste/) developed and oversees the implementation of a "fair-share" facility allocation process, coordinates the Bay Area Green Business Program, and focuses attention on critical hazardous waste management issues. Since its inception more than 15 years ago, the Committee has directed the development of innovative programs that protect the environment.

Each year ABAG analyzes data, reports on hazardous wastes generated in the region, and develops source reduction recommendations for Committee review. This process tracks waste generation trends, underlies local planning, and identifies new opportunities for collaborative action to fundamentally change the way we deal with hazardous wastes.

Of particular interest in recent years is the growing financial burden on local governments to legally dispose of hazardous household and business products such as batteries, fluorescent tubes, pharmaceuticals, computers and televisions. The Committee is supporting local and statewide efforts to promote

Extended Producer Responsibility, which would shift the responsibility for reusing, recycling, or disposing of these products away from local governments and back to manufacturers. The Committee is also participating in the Department of Toxic Substances Control's Green Chemistry Initiative, which seeks to ensure that products are manufactured with little or no hazardous/toxic substances.

To encourage and reward environmentally preferable business practices, in 1996 the Committee launched the Bay Area Green Business Program

(www.greenbiz.abag.ca.gov). This awardwinning program changes the relationship between agencies and the businesses they regulate and serve. Agencies offer technical assistance and recognize businesses that comply with all environmental regulations and voluntarily implement additional measures to prevent pollution, conserve resources, and reduce waste - all activities that also help to reduce greenhouse gas emissions. Over 1,100 businesses and public agencies have been certified. The Green Business Program is currently offered in all nine Bay Area counties. Now considered a model, the Program is expanding statewide.





In Fiscal Year 2008-09 the Hazardous Waste Allocation/Bay Area Green Business Program will:

- Monitor and support legislative and other efforts to address universal wastes through Extended Producer Responsibility and other mechanisms.
- Participate in and support Cal EPA/DTSC's Green Chemistry Initiative to promote more environmentally responsible product design that minimizes hazardous and other wastes.
- Increase the number of certified green businesses in the Bay Area to 1,500.
- Develop a web-based measurement system to track the environmental benefits of Green Business participation.
- Update the Green Business Program website.

In 2008, the Bay Trail will reach an important milestone – 300 miles of completed trail around San Francisco Bay. As the Bay Trail becomes a continuous corridor, its use as a transportation alternative to automobile travel increases.

The Bay Trail promotes positive change for a better environment by serving as a non-motorized transportation route for pedestrians and bicyclists between residential areas, schools, downtown centers, shopping, and transit. Over \$2.7 million people live within two miles of the Bay Trail, and within the same area, 98 major transit stations provide access to rail, bus, and ferry systems. A continuous trail linking transit to residential areas and downtown centers encourages pedestrian and bicycle commuting as an alternative to the automobile, thus reducing traffic congestion and fuel consumption.

The vision of the San Francisco Bay Trail is a continuous 500-mile shoreline path along the edge of San Francisco Bay that will form a trail system crossing seven toll bridges and connecting nine counties, 47 shoreline cities and over 130 local.

regional and state parks. The Association of Bay Area Governments administers the Bay Trail Project that plans, promotes and advocates for implementation. Project staff provides regional oversight and coordination, technical assistance, education and outreach, and seeks funding for planning, design, construction and maintenance.

The Bay Trail Project accomplished several major tasks in 2007: a new three million dollar grant program was launched for Bay Trail planning and construction projects throughout the region; the Bay Trail maps were updated to reflect new trail segments, waterfront destinations, and recommended hikes/bike rides; the project received an increased grant award of \$170,000 from MTC's bridge toll funds and \$60,000 from ABAG for administration of the project; staff initiated closer coordination with the Bay Area Ridge Trail Council, including a joint grant application for completion of the Carquinez Strait Scenic Loop Trail; and the project was featured on Doug McConnell's Bay Area Backroads.



The Bay Trail provides a commute alternative for cyclists, and connects to numerous public transportation facilities, including ferry terminals, light-rail lines, bus stops, and Caltrain, Amtrak, VTA and BART stations, and will eventually cross the major bridges in the region.





In Fiscal Year 2008-09 the San Francisco Bay Trail will:

- In partnership with the Coastal Conservancy, solicit, review and award grants to local jurisdictions for planning, design and construction of Bay Trail segments under the new \$3 million grant program provided through Proposition 84.
- Administer awarded Bay Trail planning, design, and construction grant contracts.
- Continue to update and use the Gap Analysis Study data to identify and initiate new spending opportunities and new Bay Trail grants.
- Pursue short and long-term funding strategies for project administration, trail development, and maintenance.
- Finalize opportunities for new Bay Trail segments through continued participation in the South Bay Salt Pond Restoration Planning Process.
- Develop new research programs to expand on the Wildlife and Public Access Study.
- Continue to work with ABAG's FOCUS Initiative and the Metropolitan Transportation Commission's Regional Transportation Plan update to highlight trails as components of a sustainable region and a regional transportation system.
- Advocate for bicycle and pedestrian access to and across Bay Area toll bridges, including the west span of the Bay Bridge and the Richmond-San Rafael Bridge as well as safe and seamless connections to the Carquinez, Benicia-Martinez, and East Span Bay bridges.
- Initiate a Regional Sign Installation Plan to identify locations for consistent installation of new signs along completed sections of the Bay Trail.
- Plan for the Bay Trail 20th Anniversary in 2009 with a series of events in coordination with regional partners to celebrate the many ways to enjoy the edge of the shoreline.
- Publish the Bay Trail Rider newsletter; establish an updated, functional Bay Trail website; meet regularly with elected officials, agency and local government staff, and media contacts; and plan and host trail dedications and other public events.

SAN FRANCISCO ESTUARY

Budget and Work Program Fiscal Year 2008-2009

The San Francisco Estuary Project and its partners completed many projects and activities in 2007 that support the Project's mandate to protect, enhance, and restore the San Francisco Bay-Delta Estuary through implementation of actions in the Comprehensive Conservation and Management Plan (CCMP). Paramount among this year's effort, the Project completed a comprehensive review and update of the 1993 CCMP resulting in an up-to-date set of priority actions which sets the framework for the Project's efforts over the next several years. Additionally, the Project organized and managed the highly successful 8th biennial State of the Estuary Conference, which was held in October 2007, and the August 2007 CCMP Public Workshop which set the specific, near-term program priorities. Completing the effort to keep the CCMP current, the Project created and distributed the 2007

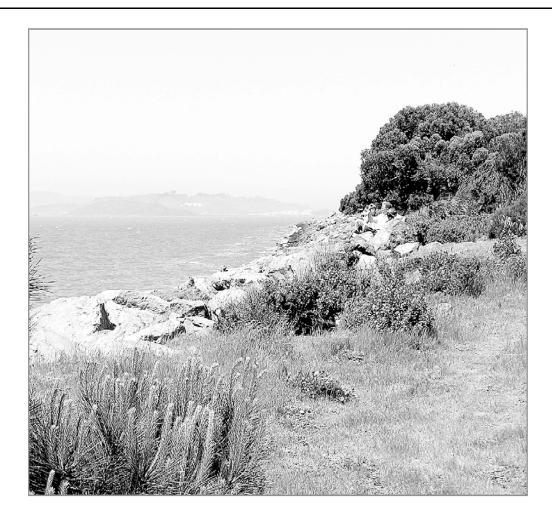

- With partners, continue work designed to prevent the introduction and spread of invasive species to the Estuary through a signage program at wetland sites describing the need for spartina eradication, and through the completion of a statewide Management Plan for Aquatic Nuisance Species;
- Technical support services to the Santa Clara Valley Water District, Alameda County Flood Control Program, Caltrans, and the San Francisco Public Utilities Commission:
- Technical and communication assistance to the RWQCB including administration of a new multi-year \$2.6 million project for implementation of Total Maximum Daily Loads [limiting pollutants into waterways of the state], and oversight of environmental projects mandated as part of the RWQCB's Administrative Civil Liability fines.
- Outreach/education through the Boater Education Program, publication of Estuary newsletter, and organization of erosion control workshops.

In 2007 the San Francisco Estuary Project updated the 1993
Comprehensive Conservation and Management Plan (CCMP)
with over 80 representatives from federal and state
agencies, local governments, environmental groups, nonprofits, private businesses, and academia in 30 work
group meetings over an 18 month period, adding 63 new
actions and revising 72 actions. The CCMP is a roadmap for
protecting the San Francisco Estuary: defining actions to restore
water quality and manage San Francisco Bay-Delta Estuary resources.



In Fiscal Year 2008-09 the San Francisco Estuary Project will:

Continue to focus efforts on projects that help to restore and protect our natural resources. In addition to the on-going projects listed previously that will continue through the next year, the Project will also:

- Assist the CALFED Bay Delta Program with organizing the three-day 5th biennial Science Conference in October with over 1200 attendees; working with the Urban Pesticide Committee to reduce pesticide use in urban creeks; writing/publishing the 2008 State of the Estuary Report;
- Work with partners, developing the application of the State's Watershed Assessment Framework as a tool for integrating and communicating watershed health indicators for the San Francisco Estuary, as part of the CALFED Bay-Delta Program; and
- Work with BCDC, the California Coastal Conservancy, and NOAA on the San Francisco Bay Subtidal Habitat Goals Project, a collaborative interagency effort to establish a comprehensive and long-term management vision for protection, restoration, and appropriate use of San Francisco Bay Subtidal habitats.

EARTHQUAKE AND HAZARD MITIGATION AND RECOVERY

Budget and Work Program Fiscal Year 2008-2009

Natural disasters come from many sources in the Bay Area, including various earthquake-related hazards such as ground shaking, liquefaction, landsliding, fault surface rupture, and tsunamis. In addition, the Bay Area is subject to various weather-related hazards including wildfires, floods, and landslides.

Mitigation programs designed to provide enhanced disaster resistance also leads to more environmental sustainability by:

- Reducing the need for debris disposal from buildings that have to be demolished.
- Lessening the likelihood of a serious hazardous materials spill from a local business whose building has been heavily damaged.
- Ensuring that sewage and other contaminants are unlikely to reach the Bay from a damaged wastewater treatment plant.



In 2007, 26 local governments completed the areaspecific portion of the multi-jurisdictional Local
Hazard Mitigation Plan, also known as an annex.

There are now 88 annexes completed in the San
Francisco Bay Area. All local governments are
welcome to participate in the ABAG Local Hazard
Mitigation Plan update in 2008.



In Fiscal Year 2008-09 Earthquake and Hazard Mitigation and Preparedness will:

Focus on securing funding for the following projects:

- Infrastructure and Environment in Levee Areas Identify critical water supply, transportation, and other infrastructure systems located in vulnerable areas protected by inadequately designed levees and work to develop cost-effective and environmentally sensitive disaster mitigation strategies for these systems;
- Housing (1) Develop ways for ensuring better quality of earthquake retrofitting of single-family homes on unanchored and unbraced "cripple walls" (the short walls between the floor and the foundation) including sponsoring legislation, and (2) inventory and encourage retrofit of multifamily housing in "soft story" buildings (buildings with large open first floors such as used for parking or commercial);
- Economy Advocate the mandatory retrofit of unreinforced masonry buildings in the downtown areas of cities; and
- Government Services Promote (1) adoption of hazard mitigation planning by additional local governments and (2) true recovery planning on the part of all local government departments, not just emergency services.

Research needed to promote positive change

ABAG's short term economic forecast and Projections 2009, the biennial estimate of long-term change in the region, will be the focus during 2008 for staff data collection and working partnerships with local jurisdictions to produce the reports. The short term forecast unveiled each January will provide a two year look at county and regional economic data and include ABAG's index of leading regional indicators and retail sales forecast. The 2009 Projections forecast will provide the basic economic and demographic information forecast extending through 2035. This forecast is also used by the Metropolitan Transportation Commission and the Bay Area Air Quality Management District in their modeling efforts.

Producing *Projections 2009* is a lengthy process and encompasses many months to collect information, produce draft results, allow comments by local jurisdictions and other interested groups, and ask for the adoption of the forecast by the Executive Board. This year's forecast process will include a more extensive discussion of the policy assumptions that have been used in the last three Projections forecasts. With the adoption of state policies to address global warming, the increased coordination between the efforts of the regional agencies, and the expected adoption of Priority Development and Priority Conservation Areas, Research and Analysis staff will be asking the Executive Board to adopt a more specific set of assumptions and relate them to various regional targets.

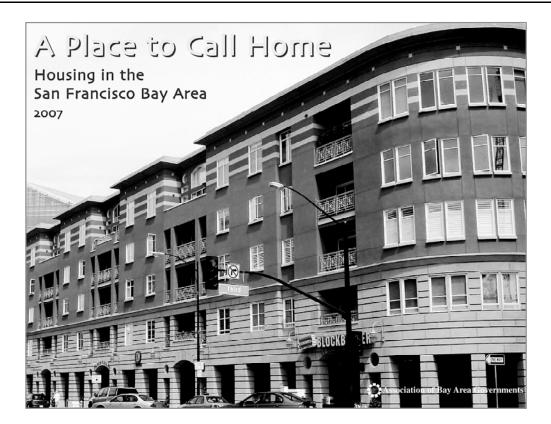
Another change beginning in 2008 is an effort by the Research group to improve our computer models. ABAG's models currently identify the location of growth around the region and are linked to extensive data bases that describe the region's existing land use and the development potential in local plans.

Improvements to these models will provide results that are more accurate, more extensive, and better coordinated with the transportation models used by MTC. The two agencies will be working together to improve and coordinate model changes.

Housing Report and RHNA ABAG will produce its third annual housing report which describes regional housing issues and tracks the production of various types of housing for the region's jurisdictions. The 2008 Housing Report will add more information on housing prices and highlight the recent changes in the housing market and the housing impact on the regional economy.

The fourth round of the Regional Housing Needs Process is expected to be completed in 2008 with the final allocation of housing need to local jurisdictions completed and issued by June 2008. At this juncture local jurisdictions will begin to revise the housing elements of their General Plans. To assist in that revision process, ABAG is developing materials and expects to tailor some of its conferences and workshops to help local governments.

Conferences and workshops will be held to brief local governments, business, agencies and community stakeholders on the highlights and implications of the forecasts and research produced. The research and planning staff will continue the Best Practices conference series began in 2007. Conferences on community engagement, housing issues, transit oriented development opportunities, and green building practices for infill areas are planned. Periodic conferences on information from the U.S. Census or special analytical topics are also envisioned.



In Fiscal Year 2008-09 Data and Analysis will:

- Begin Projections 2009.
- Produce the 3rd Annual Housing Report.
- Complete the 4th round of RHNA by June 2008 and prepare materials to assist local governments as they prepare their housing elements.
- Work to improve models that are better coordinated with MTC's transportation models.
- Plan and conduct workshops for local governments and other stakeholders.

Fifty local government entities proposed more than 100 Priority Development Areas (PDAs). The proposals comprise 115,000 acres of urban and suburban land, less than five percent of the Bay Area's total land area and could accommodate half of the Bay Area's projected housing growth to the year 2035, mostly at relatively moderate densities.

ABAG Publicly Owned Energy Resources (ABAG POWER) is a joint powers agency (JPA) formed by ABAG to acquire energy on behalf of local governments, as well as provide energy management and telecommunication services. ABAG POWER currently offers natural gas aggregation to 38 local governments and special districts in the Pacific Gas and Electric (PG&E) service territory. ABAG POWER provides a public sector approach to pooled purchasing, and each public agency is guaranteed a voice in program operations and decisions through its representative to the ABAG POWER Board of Directors and Executive Committee. ABAG and ABAG POWER are also working to expand their energy conservation services to local jurisdictions through implementation of energy efficiency and energy management

programs.

The natural gas purchasing pool has now completed its eleventh year of operation. ABAG POWER purchases natural gas on behalf of members and arranges for it to be delivered to the PG&E system for distribution. The goal of ABAG POWER's Natural Gas Program is to provide both cost savings and price stability. These goals differ from that of PG&E which is incentivized to provide low cost gas on a near-term (monthly) basis. ABAG POWER stabilizes its gas prices by layering in longer-term gas purchases, with the alternate objective of diversifying its gas purchase portfolio. The Program uses a continuous three year ahead planning cycle to design its purchasing strategy.

Natural gas prices remain somewhat below the highs that followed the 2005 hurricane season; however, prices are expected to remain relatively robust for the foreseeable future. There are many factors that can cause significant price volatility, including: abnormal weather patterns, increased demand from gas-powered electric generators, restrictions in gas transportation capacity and/or imports, the price of oil, regulatory actions, and political instability. During the next year,

the first Liquefied Natural Gas (LNG) terminal on the West Coast (Northern Mexico) is expected to become operational, potentially putting a small downward pressure on prices. However, increased awareness of environmental issues may cause regulatory actions that produce increased costs for using petroleum products, including natural gas.

ABAG Energy Watch

During the past year ABAG began work on the "ABAG Energy Watch" program for the 2006-08 period. This is a partnership program with PG&E and is designed to assist local governments achieve energy and cost savings by improving energy efficiency in public facilities and assist in creating community-wide energy savings through energy policies and programs. To date, 62 cities, counties, and special districts in the ABAG region have "enrolled" in the program to receive assistance. The program will continue to work with these agencies through the end of 2008. As entities become more active in climate protection issues, this program will assist agencies in projecting and meeting their greenhouse gas (GHG) reduction goals. ABAG intends to apply for funding to continue this assistance beyond 2008.







In Fiscal Year 2008-09 ABAG POWER will:

Continue to provide cost effective natural gas aggregation and delivery services for local governmental agencies. This will include active solicitations among natural gas marketers, and the addition of new gas suppliers, as necessary, to continue receiving the most competitive pricing. The program will pursue longer-term fixed price gas products in order to stabilize program costs.

The Program will look for additional ways of improving the customer service aspects of the program, in particular with respect to billing and analysis functions.

Although ABAG POWER primarily supplies natural gas to smaller "core" customers, it also implements a "noncore" program to supply larger facilities. Qualified, noncore customers can take advantage of lower gas transportation rates that are not available to PG&E customers. ABAG POWER currently supplies gas to three noncore facilities (City of Santa Rosa, City of Watsonville, County of San Mateo). We will continue to encourage additional participants to join both the core and noncore programs.

We intend to propose additional programs with the potential to help members reduce energy costs further through energy conservation and usage management.

ABAG FINANCIAL SERVICES

As municipal capital market conditions change, with uncertainty growing out of the upheaval in the sub-prime sector along with ever-increasing regulatory burdens, many units of local government are also facing a tightening of credit resources and more difficulty accessing the necessary investment capital for essential projects. Meanwhile, the State is generally backing away from, rather than increasing, its funding for important public service facilities.

In this uncertain and transitioning economic environment ABAG Financial Services Programs present convenient, cost saving, and secure means to meet the broad array of capital financing needs of public agencies and their nonprofit partners serving the public interest. To date, ABAG and its affiliated entities have issued more than \$7 billion in tax-exempt financing on behalf of more than 200 local jurisdictions in California.

These Programs help ABAG members to provide for construction of new hospitals and medical clinics, transit systems, affordable housing, schools, museums, water and wastewater systems, and other Member-owned infrastructure. The Agency places special focus on assisting in the construction and preservation of affordable housing, providing financing to date for more than 10,000 units in more than seventy affordable apartment communities.

In Fiscal Year 2008-09 ABAG Financial Services will:

- Continue to offer economical funding for developers of affordable multi-family housing, independent schools, hospitals, clinics, and other voluntary healthcare providers through the various programs of the ABAG Finance Authority.
- Expand the Finance Authority's capital lease financing services for member jurisdictions through the Authority's long-standing Credit Pooling Program, providing an economical source for funding equipment and smaller capital projects.
- Continue to offer comprehensive services to meet the land development financing needs of member agencies. The Authority continues to conduct proceedings for special district formation in full compliance with Proposition 218 requirements, complementing ABAG's established program for the issuance of special district financing.

The ABAG Finance Authority will also continue to offer the California Redevelopment Agency Pool (Cal-Rap), its industry leading tax-allocation bond product, as well as its credit-enhanced, pooled financing vehicle for Water and Wastewater Districts. Both of these financing pools provide extremely economical means to attain bond insurance and low interest rates for the smaller borrowing needs of special districts in the Finance Authority's member jurisdictions.

The ABAG Training Center (a program of ABAG, Inc.) has been an ABAG service program since 1979, created to provide economical alternatives for local government employees to obtain professional development training. Early course offerings were in the fields of management, environmental planning, housing, and computer technology.

Through the years, the training needs of our members and clients changed. We experienced a demand for practical, certificate courses in worker safety, hazardous waste management, pollution prevention, and computer technology. As our members experienced pressures to do more with less, the popularity of optional courses declined. As a result, the overwhelming majority of our current courses are in Occupational Safety and Health Administration (OSHA) and Department of Transportation (DOT) required safety training.

The ABAG Training Center continues to offer live, classroom training. Since late 1999, however, we have also been training students beyond the Bay Area through our web-based identity,

www.hazmatschool.com. Increasing our client base provides a means to support the continued training of our members'

employees at a reduced price, and hazmatschool.com has been very successful at achieving this goal. Enrollment and revenues for the online school are consistently increasing at more than 15% annually. More than 7,000 students have received training through hazmatschool.com each year. In total, more than 30,000 students have utilized our online training since 1999.

The market for online safety training is maturing, and the thresholds for entry by new organizations have become higher. ABAG's early entry has allowed us to develop a strong catalog of courses, a good reputation, and capable student management and course enrollment and delivery systems. We have forged a partnership with Safety Compliance Management Inc. (SCM) of San Ramon, which continues to work well. SCM provides expert course content and Remote Instructors™ who are easily accessible to online students.

We have also taken steps to affiliate ourselves with important organizations such as the U.S. General Services Administration (GSA) and the International Association for Continuing Education and Training (IACET).

In Fiscal Year 2008-09 the challenge for the ABAG Training Center and particularly for the online school is:

Ensuring that the personnel and the technical infrastructure are in place to accommodate continued growth. For the upcoming year, we will continue to update and expand content in order to make the experience more valuable to returning students taking periodic refresher courses. We will also investigate alternative methods for registering, training, and testing increasing numbers of online students. As we grow, we strive to maintain personalized service and a worthwhile training experience for our members and clients.

Our site on the World Wide Web. www.abag.ca.gov, dates back to 1994. It was the first website for a Council of Governments and the second for a California public agency. The ABAG website offers a wealth of information about the full range of ABAG's planning and service programs, including hazard preparedness and mitigation, the Bay Trail, the Green Business Program, the San Francisco Estuary Program, ABAG Financial Services, ABAG POWER, ABAG PLAN, and the FOCUS Initiative. Our web presence at www.abag.ca.gov has greatly expanded our ability to reach and help residents throughout the San Francisco Bay Region.

The ABAG website was redesigned in 2006. In 2007, the website's new look was augmented by Web 2.0 technologies, most notably a set of RSS Feeds. The RSS feeds not only provide a new service for our viewership, but enable more staff to update and contribute to our web presence. We are carefully evaluating other web 2.0 technologies, which we plan to bring on line over the coming year.

ABAG offers Internet hosting to our members and other public agencies at a competitive cost. Our hosted clients, currently numbering 28, can completely avoid the bother and expense associated with assembling and maintaining web servers and Internet domains. ABAG has also created custom websites for clients

such as the Alameda County
Transportation Authority, the San Francisco
Bay Water Transit Authority, the CALFED
Science program, the cities of Fairfax and
Orinda, and the Delta Diablo Sanitation
District.

During 2007-08, ABAG completed initial implementation of a business recovery solution to allow continued limited critical operations in the event of a variety of disruptions, ranging from an unforeseen closing of our building to a major earthquake in the Bay Area. The solution was implemented with the cooperation of the California State Association of Counties (CSAC), with their offices in Sacramento serving as the location for backup servers.

Virus attacks and spam (unsolicited email) continue to flood the Internet and our servers. At the same time, more and more applications are being handled by these servers. In 2007-08, ABAG, in cooperation with MTC, evaluated and implemented a new layer of anti-spam protection. We added additional redundancy and additional security measures to our network. We also began implementing virtual machine technology to consolidate servers, helping to conserve space and energy.

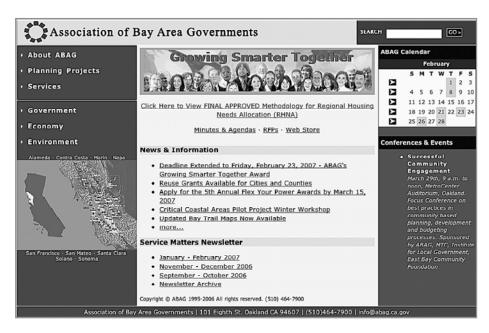

Recognizing the link between focused integrated planning and environmentally healthy communities, ABAG's Legislative and Governmental Organization Committee (L&GO) has proposed that 2008 legislative priorities include policies that embody smart growth principles, the pursuit of resources and incentives for planning. infrastructure and services to assist local governments, and solutions linking land use policy and climate change. The L&GO Committee, composed of elected officials throughout the region, has identified four critical regional issues to track during the next California legislative session: bills on housing element reform and land use, transportation efficiency and related land use policies (especially multi-modal transportation), water quality management, extended producer responsibility, and policy solutions addressing global warming. Finance reform and the fiscal impacts of potential unfunded mandates on local government will continue to be monitored closely.

Weighing in with regional priorities and innovative solutions earlier to ensure more successful outcomes will also be an important part of the strategy in 2008, the second year of California's two year legislative cycle.

During the past 2007 session, the Committee considered 46 state bills with fifteen becoming law. Six of these bills were vetoed and 16 became two-year bills. The legislation considered encompassed a wide variety of housing development, transit-oriented, infill and redevelopment issues; regional blueprint funding needs and housing element reform; local government meeting policies; water quality and land use; flood management and liability; hazard mitigation; pharmaceutical drug disposal and shifting state/local waste diversion responsibility to those who produce hazardous waste products; eminent domain; climate change policies, alternative fuels, and renewable energy.

In Fiscal Year 2008-09 Legislative Activities will:

- Increase legislative advocacy and outreach to legislators briefing them on Bay Area issues and policy solutions critical to positive change for a better environment.
- Track legislation affecting housing, transportation, and land use, and their links to better environment, water quality, and policy solutions to address global warming. Monitor closely unfunded mandates and fiscal impact on local government.

ABAG's outreach efforts were focused in 2007 on engaging and involving local governments and other stakeholders in ABAG planning initiatives and services. The Communications Department ensured that the latest updates on ABAG initiatives and research were provided to member cities, towns, and counties at symposia and workshops and through publications such as Service Matters, Risk Matters, POWER Matters, and ABAG PLAN Statement of Benefits (available in print and online), as well as timely, more extensive online news alerts. ABAG's efforts to improve and sustain a vibrant Bay Area was a critical part of information disseminated.

Visibility strategies included increased coverage of ABAG programs and services in the media and online access to conference proceedings, case studies, and presentation audio archives. Press interviews with policymakers, ABAG staff, and Executive Board members were coordinated by the Communications team to provide in-person analysis of regional issues and local government priorities.

To provide visibility to our members who are effectively advancing the cause of Smart Growth and Focus Initiatives, ABAG launched the 2007 "Growing Smarter Together" awards program. The inaugural awardees included San Mateo, Pleasant Hill, Town of Windsor, and Napa County who were recognized for their achievements in planning and building transit-oriented development, revitalizing their communities, promoting social equity,

environmental justice and community partnerships, and preserving and protecting the environment. The best practice efforts of these local governments were documented in a special DVD presented at ABAG's Spring General Assembly, "Focusing Our Vision," and each awardee was presented with a specially designed award and copy of the DVD.

The Fall General Assembly, "Bay Area on the Move," added another dimension to communication strategies and outreach. ABAG teamed with the Metropolitan Transportation Commission (MTC) for an unprecedented forum linking land use and transportation planning with climate change policy solutions. Joining the resources, expertise, and agendas of two regional agencies, ABAG outreach activities addressed priorities for land use-transportation policies and investments to accelerate support for sustainable and livable communities and improve infrastructure.

Media outreach for these conferences and other significant projects included press briefings, releases, and interviews on short term economic trends, hazard mitigation planning, regional housing issues, regional housing needs allocation process, priority development and priority conservation areas, risk management issues like sewer back-up and backflow prevention, and green business. Outreach included recognition that all Bay Area 101 cities and towns and nine counties were now ABAG members when the Town of San Anselmo was added in 2007.





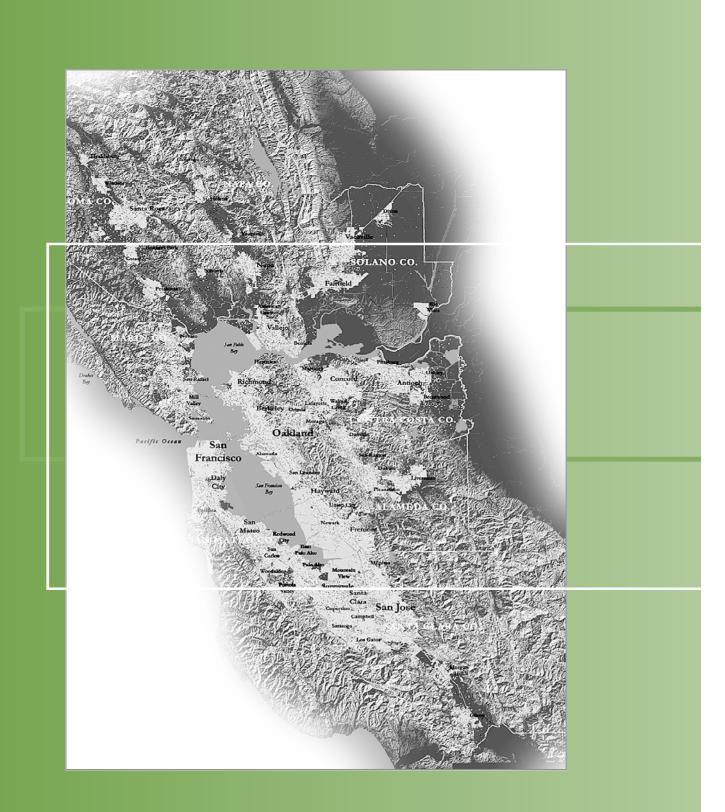

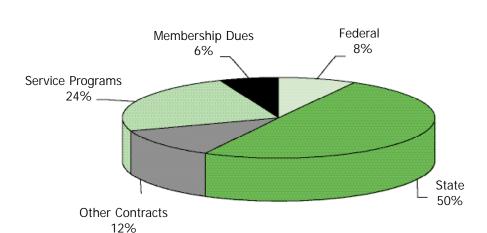

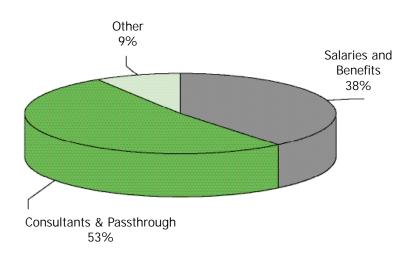

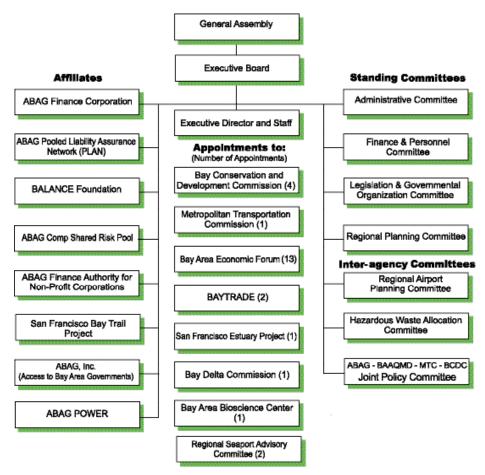
