Keep it Simple

- It is critical that communications and messaging is simple, succinct and at a level where everyone can understand:
 - Avoid acronyms and jargon
 - Speak clearly and directly
 - Tailor message to audience
 - Provide translated material and interpreters

Center Equity and Systems Change

- Center equity in all messaging and integrate new narratives that position equity as the pathway to housing solutions
- Connect the racial and economic disparities to historic policies and systems, rather than individuals

Attach and Amplify

- Understand issues community members care about and are motivated to protect
- Center housing as a foundational element to creating strong, vibrant, equitable communities
- Link housing to issues such as environmental justice, diversity, schools and other priorities for residents

Reframe

Ask the question:

How do we need to act before we lose opportunities to house future generations and preserve diversity and the small businesses that make great communities?

Avoid Challenging Different Points of View; Focus on the Facts

- Focus on the facts:
 - Identify common misperceptions and unproductive narratives and set the stage early to avoid them

Avoid the Term "Housing Crisis"

- Calling this a "housing crisis" feeds into feelings of entrenchment and sounds blameless
- Reframing this as creating "equitable housing opportunities" moves away from an "us and them" dynamic

Communicating About Affirmatively Furthering Fair Housing (AFFH)

Adopted in 2018, AFFH requires jurisdictions to proactively address patterns of segregation and foster inclusive communities in housing and community development activities.
