REPRESENTATION AGREEMENT SIGNIFYING ABAG'S UNDERSTANDING THAT MTC OFFICE OF GENERAL COUNSEL JOINTLY REPRESENTS MTC AND ABAG AND CONTAINING AUTHORIZATION TO DRAFT/REVISE DOCUMENTS PERTAINING TO LOCAL COLLABORATION PROGRAMS

Executive Summary

Effective July 1, 2017 the Association of Bay Area Governments (ABAG) staff was consolidated with the Metropolitan Transportation Commission (MTC) staff pursuant to the Contract for Services, dated as of May 30, 2017, between ABAG and MTC (CS). The CS provides in Section 3.4 that the MTC Legal Department (Office of General Counsel, or OGC) shall provide general legal support services to ABAG and the Local Collaboration Programs (LCPs). Section 3.4 further provides, "If ABAG, a LCP or MTC determines in good faith that an actual or potential conflict of interest would exist if MTC Legal Department were to provide legal services on a specific matter, then, unless the actual or potential conflict of interest is waived by the affected entities, then the affected entity whose matter gave rise to the actual or potential conflict of interest will obtain separate legal counsel." Since July 1 MTC OGC has been tasked by management with drafting documents and assisting the consolidated MTC staff in implementing the terms of the CS. These tasks include review and/or preparation of memoranda of understanding, joint powers agreements, contracts, amendments and other legal documents for ABAG and the LCPs. As part of MTC OGC's performance of such assignments, MTC has copied Kenneth Moy, asked questions of him when necessary and generally kept him apprised of work affecting ABAG and the LCPs.

MTC OGC has asked me to sign an Agreement officially memorializing this arrangement and disclosing that the arrangement reflects a "joint representation" wherein a lawyer represents more than one client in the same matter. MTC will be asked to sign a similar Agreement. As part of the California Rules of Professional Responsibility, MTC OGC is disclosing the advantages and disadvantages of joint representation, any actual conflicts of interest that MTC OGC, in its judgement, might perceive, and any potential conflicts that it, in its judgement, can identify. I note that under Section 3.4 of the CS, ABAG and the LCPs have the opportunity to raise actual or potential conflicts of interest and obtain separate legal counsel. Joint representation has the advantage of providing efficient and coordinated services to clients with identical or very closely aligned interests, at less expense than if each retained separate

counsel. On the other hand, it is at least conceivable that an attorney representing more than one client simultaneously might emphasize the interest of one client over the other, despite his or her best efforts not to do so.

MTC OGC notes in its communication that any information shared by ABAG would be open to communication with MTC and vice versa and that there would be no attorney client privilege visà-vis the other. In addition, ABAG would be precluded from disqualifying MTC in the future from having OGC represent MTC, in the event an actual conflict were to emerge. ABAG retains full right under the CS to retain its own separate counsel. Finally MTC OGC communicated to me that ABAG should seek independent legal advice before signing the document.

Recommended Action

I recommend proceeding with execution of the Agreement, subject to outside counsel's affirmative advice to do so and subject to the Administrative Committee authorizing the hiring of outside counsel to advise on the appropriateness of entering into the Agreement.
